Details of the pre-application advice received

The advice concluded that, in principle, a new café in the disused premises is acceptable, subject to complying with planning policies. Mr Allan assessed that the site is placed far enough from the residential buildings or any other structures to have no detrimental impact on their amenity.

In terms of visual impact, the change of use will not impact the appearance of The Leas as the building cannot be seen from the level of the promenade. It was highlighted that the security of the building needs to be considered as the lack of passive surveillance might encourage vandalism or breaks in.

It was advised that signage must be carefully considered to ensure it is sensitively designed, in particular signage projecting upwards from the building.

The principles of the café in this location were considered broadly acceptable in principle and Mr Allan confirmed that he would offer his officer level support for the proposal.
