To undertake the work as approved by the permissions 24/1345/FH, 24/1826/FH, and 24/1845/FH the client will require the contractor to erect scaffolding and create a temporary access for materials onto the site. This work will include the erection of scaffolding along the north east elevation of the property and the temporary removal, secure setting aside, and subsequent reinstatement of a window on the fourth floor. This window has a rotten sill that will be replaced with a like for like timber sill upon the reinstatement of the window at the end of the building works.

The client would also like to replace the three roof lanterns, rather than repair as approved in application 24/1826/FH, which is impracticable. The replacement roof lanterns will be a like for like replacement, with double glazing opposed to the existing single glazing and Perspex.
