Details of the pre-application advice received

Taking the site and its surroundings into consideration, there is concern that the proposed extension to form a two-storey building would result in development that would appear as a bulky and dominant addition in the streetscene where all other development forms single-storey buildings. There is concern that the resultant development would appear visually out of scale when read alongside the other nearby subordinate buildings and this concern, combined with the cladding material would result in development that would appear overly dominant by failing to relate to its surroundings.

In addition, due to the differing land levels, the ridge of the resultant building would sit almost 1m higher than the ridge of the community building in front. It is not clear what, if any, visual impact this would have from Broomfield Road. This could result in visual harm, especially when considering the material finish.

With regard to neighbouring impact, it is not clear if there are any rear-facing windows in the community hall, but given the close proximity and the community uses, it is unlikely that the first-floor west facing windows would give rise to unacceptable overlooking.

It is possible that the east facing windows would be unacceptable as they would allow direct overlooking to the rear elevation gardens/windows of the houses in Park Road. This concern could however be overcome by their removal or the use of obscure-glazed, non-opening windows.

To conclude, based on the information provided there is concern regarding the scale and material finish of the development and its visual impact on the character of the streetscene as a result where the pattern of development is of single-storey subservient outbuildings.
