The proposed extension will result in a small extension at the west of the building, however this extension comprises a footprint of approximately 13.2 sqm. which is lower than the 25 sqm. threshold. In addition, the area on which the extension was created did not comprise grassland but instead decorative stones. As such, the proposed extension did not affect any onsite habitat and therefore confirms that the 'de minimis' BNG exemption would be applicable to the proposed development.
